**TERMS & CONDITIONS**

**AIRLINE PASSENGER SERVICES:**

Round trip air transportation from / to the United States will be via economy class jet service aboard IATA and ARC carriers, utilizing APEX or SUPER APEX non-refundable tickets for groups flying together on the entire itinerary. International flight times will be confirmed approximately 30 days prior to departure. Once tickets have been issued, they cannot be refunded or exchanged and are subject to cancellation penalties. Your flight times are subject to change without advance notice as the airlines have control over their schedules. PVT will make every effort to keep you advised of any changes in flight times, however, PVT is not responsible for changes and delays in airlines schedules and does not reimburse passengers for expenses resulting in delays. We strongly recommend the purchase of a Travel Protection Plan (Insurance). If airlines change flight schedules, we reserve the right to lengthen or shorten the itinerary accordingly, which may result in a corresponding cost increase.

**FUEL, SECURITY AND TAX SURCHARGES:**

In the event the airlines or other suppliers should impose a fuel, security or tax surcharge, a supplemental invoice will be sent to you and is payable in full on or after November 15, 2006.

**BAGGAGE:**

Due to limited motor coach capacity for baggage, you will be allowed ONE SUITCASE plus one carry-on flight bag. Garment bags cannot be handled. Additional luggage is subject to a supplementary charge. Portage for one normal sized suitcase is included at all overseas airports and hotels and has been prepaid for you. Baggage insurance is recommended to cover possible loss or damage to your luggage or personal belongings.

**GRATUITIES:**

Included in the cost of the Holy Land Pilgrimage are gratuities to porters at the international airports (not USA) and hotels, services of hotel front desk employees, chambermaids, dining room waiters and chefs, as well as standard gratuities for the tour guide and drivers. Additionally, the customary Love Offering in appreciation of the services provided by your tour guides and drivers given at the end of your tour is included. You are welcomed to offer a gratuity of your own.

**CHILDREN AND PHYSICAL DISABILITIES:**

Children age 7 and under cannot be accepted on this pilgrimage. Any members requiring assistance due to physical limitations must be accompanied by a companion who will take full responsibility of accommodating those needs. PVT will not assume this responsibility. Motor coaches used on this Pilgrimage are not wheelchair accessible.

**ITINERARY CHANGES AND HOTEL SUBSTITUTIONS:**

PVT reserves the right to make necessary changes and adjustments to the itinerary to improve and enhance in whatever ways deemed necessary without hindering the enjoyment of the Pilgrimage. PVT also reserves the right to substitute hotel accommodations, only when necessary and will provide a similar hotel property of the same standard.

**CANCELLATION, PENALTIES AND REFUNDS:**

PVT must receive all cancellation requests and refund claims in writing. We strongly recommend the purchase of cancellation insurance to cover penalties imposed. (Not all cancellation reasons are covered by insurance, please review policy application) No refunds can be made for unused portions of the Pilgrimage. From day of registration to 90 days prior to departure, a \$250 per person non-refundable administrative fee plus any airline penalties will be assessed. From 89 to 60 days prior to departure, a \$500 per person penalty plus any airline penalties will be assessed. From 59 to 45 days prior to departure, a \$600 per person penalty plus any airline penalties will be assessed. From 44 to 31 days prior to departure a penalty of 25% of the per person cost and from 30 to 15 days prior to departure a penalty of 50% of the per person cost will be assessed. From 14 days prior, to day of departure a penalty of 100% of the per person cost is assessed.

**SINGLE AND DOUBLE OCCUPANCY RATES:**

The \$3,200 per person rate is based on double room occupancy. That is two people each paying \$3,200 and sharing one room. Single occupancy rooms are subject to availability and are usually smaller than the twin or double rooms. If you do not have a traveling companion we will make every effort to match you with a compatible roommate. If roommate is not available or you do desire a room by yourself, a single occupancy supplement of \$550 will be charge. The single occupancy rate is \$3,750. Room occupancy by more than two people is not allowed.

**DEPOSITS AND FINAL PAYMENTS:**

A \$400 per person deposit along with a completed registration form is required to secure your confirmed reservation on the Tarrytown United Methodist Church Holy Land Pilgrimage with Rev. Ron Campbell. Final payment is due no later than November 15, 2006. Full payment may be made at any time prior to November 15, 2006. Installment payments may be made between your registration date and the final due date of November 15, 2006. PVT will work out a payment schedule that meets your requirements. Checks should be made payable to: PARADISE VACATION AND TRAVEL CO., INC. and mailed to 5725 Misty Hill Cove, Austin, Texas 78759. If you prefer to use a credit card for your payments, a separate credit card authorization form will be sent to you. Please complete all information and return with required documentation.

**PASSPORTS AND DOCUMENTS:**

It is your responsibility to have a valid passport in your possession at all times during this Holy Land Pilgrimage. The passport should not expire any earlier than September 30, 2007. In addition, you must supply a photocopy of your passport to PVT no later than December 31, 2006. If you need to obtain or renew a passport, please call PVT and we will advise you of the steps necessary and locations for passports.

**PILGRIMAGE LIMITATION:**

Confirmed registrations are on a first come basis and are limited to the first 80 people (2 touring buses) or December 31, 2006 which ever comes first. After which you will be placed on a stand by waiting list.
