AIRLINE PASSENGER SERVICES:

Round trip air transportation from / to Austin, Texas and Los Angeles, California will be via economy class jet service aboard IATA-ARC carriers, utilizing non-refundable tickets for groups flying together on the entire itinerary. Flights and times will be confirmed approximately 30 days prior to departure. Once tickets have been issued, they cannot be refunded or exchanged and are subject to cancellation penalties. Your flight times are subject to change without advance notice as the airlines have control over their schedules. PVT will make every effort to keep you advised of any changes in flight times, however, PVT is not responsible for changes and delays in airlines schedules and does not reimburse passengers for expenses resulting in delays. We strongly recommend the purchase of a Travel Protection Plan (Insurance). If airlines change flight schedules, we reserve the right to lengthen or shorten the itinerary accordingly, which may result in a corresponding cost increase.

FUEL, SECURITY AND TAX SURCHARGES:

In the event the airlines or other suppliers should impose a fuel, security or tax surcharge, a supplemental invoice will be sent to you and is payable in full immediately upon receipt.

BAGGAGE:

Due to limited airline and motor coach capacity for baggage, you will be allowed ONE SUITCASE not to exceed 50 pounds, plus one carry-on flight bag. Additional luggage is subject to a supplementary charge. Portage for one normal sized suitcase is included at our hotel and has been prepaid for you. Baggage insurance is recommended to cover possible loss or damage to your luggage or personal belongings. Baggage gratuities at the airports are not included.

NOT INCLUDED:

All gratuities are your personal responsibility. Meals except where indicated and all other items of a personal nature.

CHILDREN AND PHYSICAL DISABILITIES:

Children age 2 and under cannot be accepted on this Tour. Any members requiring assistance due to physical limitations must be accompanied by a companion who will take full responsibility of accommodating those needs. PVT will not assume this responsibility. Motor coaches used on this tour are not wheelchair accessible. Rose Bowl seating in this Tour package is NOT ADA qualified.

ITINERARY CHANGES AND HOTEL SUBSTITUTIONS:

PVT reserves the right to make necessary changes and adjustments to the itinerary to improve and enhance in whatever ways deemed necessary without hindering the enjoyment of the Tour. PVT also reserves the right to substitute hotel accommodations, only when necessary and will provide a similar hotel property of the same standard.

***REFUNDS, CANCELLATION, AND PENALTIES:**

All deposits and payments received for the 2006 University of Texas Rose Bowl Tour package are fully refundable if The University of Texas were not to receive an invitation to the 2006 Rose Bowl National Championship game played on January 4, 2006. Full payment is due no later than December 3, 2005. Once an official invitation is extended to The University of Texas for the 2006 Rose Bowl National Championship game, all payments become NON-REFUNDABLE. Anyone with a registration under deposit and not paid in full by December 3, 2005 will forfeit the deposit and inclusion on this Tour. Once a registration form is received with the appropriate deposit/full payment it is non-cancelable (subject to official Rose Bowl invitation). Names may be changed once prior to December 3, 2005. After December 3, 2005 no name changes are accepted. PVT must receive all requests for name changes in writing. We strongly recommend the purchase of travel insurance. We will forward an insurance application to you upon receipt of your registration form.

DEPOSITS AND FINAL PAYMENTS:

A \$500 per person deposit or full payment along with a completed registration form is required to secure your confirmed reservation on The University of Texas 2006 Rose Bowl National Championship Tour package. Final payment is due no later than December 3, 2005. Full payment may be made at any time prior to December 3, 2005. Installment payments may be made between your registration date and the final due date of December 3, 2005. PVT will work out a payment schedule that meets your requirements.
